



2008 Competition

Football Far North Coast is calling for applications from member clubs to participate in a Summer Youth League Competition.

Competitions will be available for both males and females for players aged between 15 and 20 years. Players must have turned 15 and must not have turned 20 prior to the commencement of the competition.

The aim of the league is to develop players and assist with the transition from junior to senior football. As a condition of entry clubs must engage a suitably qualified coach with a minimum of a current FFA Youth Licence.

As part of the development program players and coaches will be expected to attend development sessions with FFNC Coaching & Development Manager and guest coaches.

Competition fixtures are to be held on a Friday or midweek as required, to assist clubs in attracting suitable players and to avoid conflicts with traditional summer sports. All fixtures will be scheduled to be played under floodlights to avoid unsuitable playing conditions.

The competition will commence the week of Monday 13th October and conclude the week of Monday 19th December. The format of the competition will be home and away with a maximum of ten teams divided into two pools of five. A finals series will be played with the format dependent on the number of teams participating.

Should a club be unable to field a team in their own right consideration will be given to a combined side incorporating no more than three clubs. Only one home ground will be accepted to host fixtures.

All players must be registered with Football Far North Coast for the duration of the competition.
